30TH SUNDAY IN ORDINARY TIME — OCTOBER 29, 2023

"You shall love the Lord your God with all your heart, and with all your soul, and with all your mind." "You shall love your neighbor as yourself." These are two of the greatest commands the Lord shares with those asking Jesus trick questions to trip Him up. This is the Commandment by which we are called to live our everyday, ordinary life. The Commandment that Jesus refers to as the most important or greatest is also the Commandment by which we will be judged at the end of our lives. Something in the articulation by Jesus of the greatest Commandment is so clear and simple and easy. It is all for the Glory of God that we would do these things. However, in our day-to-day lived out expression, it gets complicated and frustrated by our unwillingness to heed the way. Once again, let's take some time to put this hope before God in prayer, that we may be found worthy and live lives in simplicity and in profound joy as we abide in the Commandments God has given.

Month of November - All Souls – During the month of October, we were given an opportunity to reflect on the wonderful mysteries of the Holy Rosary of our Blessed Virgin Mary. As we move into the month of November this coming week, we are invited to remember to pray for All Souls. NOTICE OF SETTLEMENT IN CLASS ACTION

To all individuals who were sexually abused by a priest of the Roman Catholic Episcopal Corporation of Halifax or Roman Catholic Episcopal Corporation of Yarmouth between April 14, 1954 and March 31, 2020 and have not previously settled or otherwise released either the Roman Catholic Episcopal Corporation of Halifax or Roman Catholic Episcopal Corporation of Yarmouth.

The Court has approved a settlement which provides compensation to eligible class members who file a claim for sexual assault and meet the requirements of the claims process.

If you opted out of the class action, the settlement will not impact you.

If you are part of the lawsuit as a Class Member, you can submit a claim for a payment of money as compensation. The amount of money that you may receive will depend on the specifics of the claim you submit. The potential amount of money to be paid to a Class Member whose claim is accepted will likely range from \$30,000 to \$350,000.
